2) BUSINESS I. Strategic Planning Discussion	<p>Reported that our Strategic Planning process is a five year cycle with our next plan due in the 2011/12 calendar year. A thirty month cycle has been developed that will allow our college to get into the details of where we are and where we want to go. Thirty month calendar <p>The goals for this process are to have extensive student participation, deep and broad engagement with faculty and staff, and new formal lines of dialog with key external stakeholders. Noted that we still need to assess our College Planning Structure which can be part of this process.</p> <p>Reported that tyhe District Office responded rapidly to the concerns students had regarding campus food service and eating spaces on campus. President Mohr, Tom Bauer - Director of Auxiliary Services, Jai Kumar – Bookstore Manager, and Rick McMahon of Pacific Dining met with ASCC students on January 22nd to discuss campus food services in place and other related concerns the students had. President Mohr that same day also walked around the campus with some of our students in search of eating spaces for students. The Bookstore and Pony Espresso will be carrying more lunch items to include salads and sandwiches. A microwave will be available to students at the Pony Espresso. Tables on campus have been relocated and additional ones have been ordered.</p> <p>The ATM will be moved to the first floor of Building 9 in front of the Public Safety Office.</p> <p>DSPS and Psychological Services have moved to Building 9</p> <p>The Staff Lounge was moved from 9-154 to 9-123.</p> <p>EOPS Lounge was moved to the EOPS workroom.
