# 4) Reports (2 minutes)

a) "Why" We Do What We Do Share (Maria Huning)
2 mins
i) An instance that has happened recently that has reminded you why you do what you do to challenge equity and anti-racism in Student Services?

Maria Huning, Director of the TRIO Program at Cañada College, is sharing with us today from Sequoia High School. "I help to foster the pipeline from the high school in our community through to the college and beyond. In TRIO I feel this is very possible because we are able to obtain a grant that will fund these type of direct services to our community through our partner programs like Sequoia High School, Woodside High School and community partners like the Fair Oaks Community Center or the Adult School. A big part of what I do what I do is because we have community members and families that slip through the cracks and I feel like that is how my family was as well. As a family we had some education around how to do certain things but it was through programs like TRIO that I was able to continue on in my education. I was lucky enough to attend Mills College and there I met the TRIO Director there that could see I was lost. He helped me through the beginning of my education and to find a path. I feel like it's my opportunity to offer that hand back to our community and keep the pipeline moving forward."

### SparkPoint Updates:

Food Grant Program - Nearly 400 students are receiving a \$75 monthly electronic Food Card to be used at either Target, Safeway, Walmart, Whole Foods, Instacart or Uber Eats.

Rapid Response Hotel Stay Program - We have expanded our 3-6 night hotel stay to 30 nights for students experiencing homelessness or who are near homeless.

Rental Assistance - Students in need of up to 2 months of Rental Assistance, rental assistance is available. Students are also connected to local CORE Agencies to access additional financial assistance (car repairs, additional housing, food and additional services).

We are planning to open the Food Pantry in January of 2022.

**Transfer Center** is hosting a virtual transfer Day of October 26th from 11 a.m. to 2 p.m. There are about 65 in-state and Out-of-state universities.

a) PBC

Our last PBC was on October 6. We took action based on Assembly Bill <u>AB 361</u>. This bill amends the Brown Act to allow groups to continue holding meetings in a virtual format through the fall semester due to COVID-19.

There was also a presentation on the Facilities Master Planning from Vice Chancellor Jose Nuñez. Vice Chancellor Nuñez reviewed the Master Plan Goals, which are designed to honor and support the District's strategic goals and the College's Educational Master Plan.

*b*) VPSS Updates

We look forward to our first Student Services Huddle on Friday, October 29 in the afternoon. Invites will be going out this week. It will be a time to gather outdoors with snacks and an opportunity to speak with each other in an open forum to talk things out with one another. Our hope is to have this on roof top patio of building 23.

Our Town Hall is this Friday with an opportunity to hear from a College specific lens about District wide efforts to clarify vaccination uploads, documentation and exemptions, student vaccination process, etc.

Keep in mind that our students have received two messages and will receive two more with information that they need to update their vaccination information for Spring classes by November 3 to avoid disruption and limiting restrictions to in person classes in the Spring. Students will receive a step by step process on Websmart on how to upload their information, as well as, on the letters sent to students.

Question: Is it required that we have the booster shot? No, we just need the first two vaccinations.

c) Enrollment Services Committee Update Wissem & Maria L./ 15 mins

Beginning Friday, December 17 at noon through January 4 Degree Works is going through a major upgrade so it will going down. Students will be notified prior to December 17 by email instructing them to please print or save their SEP so they know which courses to enroll for in the Spring 2022 term. This important information will be placed on the Degree Works page as well as emailed to each student.

On our Admissions & Records main page you can go to the <u>COVID 19 Grading Tab</u> regarding information for the Fall 2021 EW pass/no pass and incomplete guidelines as it relates to COVID. This information is the same for all three campuses.

There was a miscommunication with IT and the Fall 2021 was not set up for EWs so when students were dropping from the courses between September 1-16 they did not have the option to pick COVID related. This was fixed and IT was able to go back to all the students who dropped themselves via Websmart and corrected that mistake. It should now reflect an EW and the student should also receive a refund.

The deadline to drop a course with no charge for the Fall 2021 semester is the <u>last day of</u> the course. Each course will be different. The dates are posted under the webschedule.

Priority Registration dates for Spring 2022 are November 3-16 Open Registration is November 17-January 17. Late registration is January 18-31

The registration dates are updated on the Admissions & Records website

CCCApply is now open. If students are wishing to apply using CCCApply for the Summer 2022 term or Fall 2022 term, they can do so.

For current Fall 2021 we have extended the deadline to submit both degree and certificate graduation petitions from October 1 to November 5, 11:59 pm. Please refer students to Counselors for an appointment.

The Director of Student Success position has posted. This is a joint position managing the Learning Center and Student Success Teams and Guided Pathways.

We did a deep dive discussion from both an equity and antiracism lens around success teams and pathways for part-time students, first-year experience, dual enrollment and early college, as well as, career exploration. We discussed what the priorities will be for us this year.

We also discussed what has and hasn't worked well for Guided Pathways and Colts Con so we can improve. We also discussed how Guided Pathways eco system works in our college and if we are student ready.

## 6) Business Items (70 mins)

a) Faculty & Classified Request Forms

Max is on the Program Review Workgroup as representative through PBC. This workgroup is to continually refining and updating our Program Review process. While we've had a lot of work upgrading the process for non-personnel, we've found we now have an opportunity for updating the process on how we request personnel positons. If you are going through Program Review now and requesting personnel positions, complete either the Program Review or Annual update, as well as, the Classified Request forms. SSPC reviewed the Faculty and Classified forms which are included in the minutes packet.

The ask is to have SSPC review these forms and collect feedback and get recommendations for how we would like the forms and the process to move forward. The Program Review workgroup is planning to also send a survey to all employees requesting personnel positions during this Program Review process to get specific feedback from them.

This is for the future and does not impact the current Program Review process.

b) Vaccination Check-in & Updates

The Town Hall is Friday, October 15 and will center on the student vaccination process.

Question: Outreach would like to know as soon as possible when we can invite other students, such as High School students and community organizations for Outreach Tours. As it relates to this semester for anyone who is not a student, we have our universal mask mandate for this semester only; Fall 2021.

At the Town Hall tomorrow we'll receive more specific policies and practices for Spring 2022.

President Lopez added that at Chancellor's Cabinet they are in the process of debating the mask mandate for Spring 2022 so we hope that decision will be made soon.

Question: Will vaccination clinics continue through Spring 2022? The vaccine clinics will continue but they will be consolidated to the District Office. They've been consolidated because of the low turnout at the colleges. There is ongoing conversations regarding have vaccines available at the college Health Centers. More to come.

Please continue to remind and encourage our students to upload their vaccination data beginning on Nov. 3! This is to avoid any restrictions to in person services and classes.

c) President Salutations

President Lopez has asked all the Division Deans and Vice President's to invite her to their meetings so she can say hello.

President Lopez wanted to see if anyone has any questions or concerns to bring to her.

The President's Office is in the process of collecting questions regarding student vaccinations and will compile them and bring them to the Town Hall tomorrow.

We've received a lot of questions from the Health and Safety Committee, as well as Academic Senate. We've combined these questions and will get them answered and sent back out to the committee and academic senate. I hope you'll have the opportunity to review these questions and answers before the Town Hall on Friday.

We've added a standing item to our Planning and Budgeting Council meetings which is Spring 2022 Return. Every other week we will provide updates, share decisions and answer question or bring them forward to Chancellor's Council to keep the communication of information open.

d) SSPC Focus Areas (cont'd from SS Manager's Meeting update) All / 30 mins.

During the summer the Student Services Manager's met and in that meeting we discussed the broader budget from both the statewide system and bringing communication full circle in Student Services. To better communicate, we will continue having Student Services Planning Council meetings, we will have at least two more Student Services Manager's meetings and we'll begin Student Services Huddles.

During these meetings and conversations, we've discussed what do we want to do as a planning council? As part of our by-laws, we already know that we offer strategies and resources for strengthening student services practices, student services long term, short term, and mid-term goals. What do we want our planning council to focus on this year?


Below is an info graphic that talks about the 4 I's for informational leadership. Let's use this as we take a look at the work that we do.

The leaves are talking about idealizing influence or the way in which we, as a group of leaders, can be role models. That we act, communicate, relate and empathize with one another with the goal of setting standards.

Take note of what comes up for you as you reflect on the graphic.


How do we connect and/or how do we relate to the info graphic?

The space needs a name!


