## 5) Standing Items

a. PBC

The last meeting for the Planning & Budgeting Council was March 2, 2022.

An overview of the Presidential search process and timeline was discussed. There was a special presentation and reminder of where we are right now with our Educational Master Planning process. There is a retreat happening on Friday to go over next steps.

There was discussion on our Spring enrollment as it relates to both data and trends and important questions. Dr. Bennani and Dr. Engel anchored the conversation from a place of data and best practices which included enrollment landscape but also some vaccination and attestation information and data, as well as, some top issues and trends that are taking place in the enrollment world as it relates to applications and financial aid and what we've done to look at those concerns.

We also discussed planning for our Fall 2022 semester and continued return to campus.

The next PBC meeting will be Wednesday, March 16, 2022.

b. VPSS Updates

We're getting closer to the end of the semester and it's a good time to check in with each other from a Student Services stand point.

c. Enrollment Services Committee Update Wissem / 4 minutes

At the last ESC meeting we discussed a lot of technical issues.

The work to get the forms into the CRM is in process. The work is going well. The Registrars plan to complete their part by the end of this month. The work continues and we will all appreciate this part of the CRM once it's completed.

Texting is prioritized as a communication tool. Ana Pulido has taken the lead on this project and is working on the technical side but also researching to make sure departments are trained and organized on standard procedures so we remain in compliance.

Parchment is now available for students to receive certificates and degrees electronically. Then they'll be able to share their certificates and degrees via LinkedIn or any social media. Parchment will help us speed up the process. Once electronic students will be able to receive their certificates and/or degrees within two weeks. Attestation: Students who have already attested and have been approved to be in oncampus classes or have an exemption, will be automatically approved for Summer 2022 and Fall 2022. There will be a roll-over and they will not be asked for anything.

New students will need to attest prior to registering for in-person courses.

The deadline to petition for Spring 2022 degrees and certificates has been extended to April 1, 2022.

April 1, 2022 is also the deadline for students' names to appear in the Commencement program. Marketing will be sending an announcement out for students who are graduating to make an appointment with a counselor as soon as possible.

d. Guided Pathways

At the last Guided Pathways meeting we discussed reassign time for faculty leads and Counselors.

We also talked about success navigators and their role in the Success Teams. They were invited to the Retention Specialists Communities of Practice meeting to talk about the matriculation process and what that is and how students move from Success Navigators to the Success Teams.

We discussed the differences between Interest Area workgroups and the Success Teams. These areas still seem to need some clarification.

There was discussion on the updates with the Priority Action items. We talked about First Year Experience, Orientation, PEPs and ColtsCon and what these will look like. For Dual Enrollment we discussed scheduling and identifying courses from the High School partners and the existing pathways that we have.

Career Exploration has moved forward with the Program Services Coordinator which is being paid for by Strong Workforce.

a. COVID-19 Student Services Roundtable

Should we be planning for our Summer and Fall semesters to be 100% on campus or has there be discussions about some form of hybrid?

We're waiting to hear from the Board of Trustees for their decision. The masking conversation is being prioritized. Manuel will bring this question to the VPSS meeting too.

Can we adjust the messaging on the vaccination policy? Wording could be clearer about having to be vaccinated. We may get updates soon from the Board.

Here is the message: Cañada College, College of San Mateo, and Skyline College are requiring all students to be vaccinated against COVID-19 in order to take in-person courses, and receive in-person services (Admissions and Records, Counseling, Library, Tutoring, etc.). If you wish to take in-person classes or receive in-person services, you must provide proof of vaccination or your documented reason for an exemption. If you do not provide proof of vaccination or if you are not approved for an exemption, you may only take online courses and receive virtual or remote support services. To upload your proof of vaccination, go to WebSMART (found on the mySMCCD Student Portal), click on "Student Services", then click on "COVID-19 Vaccination".

NOTE: In order to attend in-person appointments or events on-campus, you must have your COVID-19 vaccination or appropriate exemption approved before arrival.
