b. Transportation initiative allocations and discussion	<i>President Santos/ 10 minutes</i>
	President Javier Santos informs the members about a recent agreement that he had made with SamTrans. SamTrans is willing to let the college be a vendor for their tokens so that they can be more accessible to students that take the bus regularly. Javier shares that the average price for ten bus

tokens is sixteen dollars; however, the ASCC might be able to subsidize the price. **Javier** reinforces that being a part of this initiative will be beneficial to a large number of students.
