## **7.2 Posting of Program Reviews Online**

ASGC discussed whether to post the Program Reviews online. Key points are listed below.

Background: At this time, Students Services program reviews are posted online. Instruction program reviews are available via SharePoint only. CSM has all Program Reviews available to the public.

Concerns: Confidentiality – especially with small programs. How can we preserve student anonymity?

Consensus: All Program Reviews should be posted online. Benefit of having everything public makes everyone able communicate effectively. Goal is to have them all posted online before the site visit.

## **7.3 Representation of faculty without a Division (Athletics and Library) on the Governing Council**

Effective Fall 2013 the restructuring of the divisions is as follows: Business Design & Workforce. Kinesiology, Athletics and Dance is now under the VP of Instruction. Formerly Ana Miladinova was the “Business, Workforce, and Athletics” representative. Since Kinesiology, Athletics and Dance no longer meets with the Business division, how shall these two groups be best represented on the Governing Council?

What are the goals of ASGC? How should membership take place? How does Business/Workforce want to be represented? What about the Library?

Need to revise our ASGC bylaws. The Business/Workforce division will be contacted to determine next steps regarding representation on ASGC.

8. Time with the researcher
