Textbook Affordability Subcommittee Report for ASGC Meeting of 8 Sept 2022

Fall 2022 Numbers

Amazing! We saw a significant increase in adoptions of zero-cost and low-cost materials for our fall courses. Some of this was due to better reporting; in other cases, it was due to folks making switches in their course materials. *On behalf of our students, thank you!!!*

The latest numbers—with more data coming:

- 2,280 students enrolled in a ZTC or LTC section as of Census Date (162.86% increase from F21)
- \$213,800 estimated savings based on enrollment (156.98% increase from F21)
- 96 sections of 73 courses as ZTC (~170% increase from F21)
- 9 sections of 7 courses as LTC (~200% increase from F21)
- 53 total faculty teaching ZTC/LTC courses.

State Funding for Z-Pathways

The State Chancellor's Office has finally announced information about its funding of zero-cost pathways. With the \$115 million given to us by the AY21-22 budget, the funding is being broken into 3 phases. *The core focus is on creating zero-cost programs (degrees for transfer and certificates).*

- Phase 1: \$20,000 for each college in order to prepare for Phase 2. Each college needs show what they
 plan to do with those funds.
- Phase 2: Grants of up to \$200,000 per program application. This is a competitive grant, but there should be room for most who apply.
 - The project details are very similar to the ASCCC OERI Request For Proposals, and collaboration across colleges is allowable.
 - o The idea here is heavy remixing and/or authoring of materials, support to get the work done.
 - Should be something that can be institutionalized
- Phase 3: Whatever remaining money will be offered up as grants—more on this in about a year.

We're set up pretty well, both as a college and a district, but we have more work to do. Ideas for Cañada include:

- Using Phase 1 money for a spring-only cohort of the ZTC Adopter Program. (We'd also run our usual cohort in spring/summer.)
- Using Phase 2 money for ADT/Certificate programs that are close and need some boosting—can be used for training, stipends/awards, and other support.
 - o Programs that are at least 80% ZTC: ANTH, ECE, General Education (IGET-C, Cal GET-C)
 - Programs that are ~50% ZTC: PHYS, COMM
 - District-wide need for data/research support
