

# ASCCC OERI Projects Update

It's time to provide a quick overview of the OER projects that the OERI has funded. Round III is in-process, and Round IV was just announced.

RFP III was funded in May 2021, and the work will be ready for the end of 2022/beginning of 2023. The following projects were funded, and have connections to disciplines taught at Cañada:

- Anthropology:
  - Anthropology elective courses focusing on magic, witchcraft, and religion: *Beliefs: An Open Invitation to the Anthropology of Magic Witchcraft, and Religion; A complete OER textbook*
- Art/Art History:
  - C-ID ARTH 110: *Introduction to Art History I: an OER Textbook for Survey of Western Art from Prehistory through the Middle Ages*
  - C-ID ARTH 120: *A World Perspective of Art History: 1400 CE to the 21st Century*
- Child Development:
  - C-ID CDEV 110: *Child Family Community OER Revision*
- Communication Studies:
  - C-ID COMM 150: *Intercultural Communication Instructor Resource Manual*
- CTE - Various:
  - CTE health and safety courses: *Workplace Safety for US Workers-A practical guide for understanding Health and Safety programs for skilled labor professionals: OER textbook, workbook, and ancillaries for CTE program certifications*
- Early Childhood Education:
  - Infant/Toddler Development and Infant/Toddler Care and Education: *One textbook with 39 sections or mini-chapters in the LibreTexts platform to support Curriculum Alignment Project (CAP) expansion courses: Infant/Toddler Development and Infant/Toddler Care and Education.*
- English:
  - C-ID ENGL 100 and 105: *New content, revisions, and a teacher's guide to enhance an existing textbook for C-ID English 105 and extend it to C-ID English 100*
- ESL:

  - Library Services: *Foundations of Library Services Original OER Textbook*
- Physics
  - Astronomy and physics: *Online Question Banks and My Open Math Course Template for Introductory Astronomy Courses that Utilize OER Textbook Astronomy by OpenStax and Additional Online Questions and Features for CCC Lower-Division Physics Courses (C-IDs: 105, 110, 205, 210, and 215) that Utilize OER Textbooks by OpenStax*
- Political Science
  - C-ID POLS 130: *New OER for Introduction to Comparative Government and Politics with Chapter Lecture Slides*


# ASCCC OERI Projects Update, cont'd

RFP IV was just announced in mid-February. These projects will come out mid-late 2023. The projects that were funded and have connections to Cañada disciplines are:


- Anthropology:
  - C-ID ANTH 110: *Explorations, Second Edition: An Open Invitation to Biological Anthropology* (CC BY-NC, 2019). An updated, expanded, equity-minded OER textbook
- Ethnic Studies:
  - *New Directions in Chicanx and Latinx Studies OER Textbook and Ancillary Materials*
  - *OER Textbook and Ancillary Materials for "Introduction to Ethnic Studies"*
- Geography
  - C-ID GEOG 125: *Contemporary World Geographies, a textbook-equivalent OER for World Geography*
- History
  - C-ID HIST 160: *Integrating Social Justice, Equity and Antiracism Themes in World History Since 1500*
- Math
  - C-ID MATH 240/250: *Linear Algebra and Differential Equations MyOpenMath Assignments and other Ancillaries*
- Spanish
  - C-ID SPAN 100/110: *Tarea Libre: First-Year Spanish OER Homework Question Bank in LibreStudio and ADAPT*

It should be noted that in both of these RFP's, there are SMCCCD folks involved. Great work by all who are participating!

It is anticipated that RFP V will be announced in the coming months. If you have an idea for an OER textbook or ancillary, and would like support and collaborators, then keep a lookout for the announcement!



# Update on the OER/ZTC Implementation Plan



In our November/December newsletter, we indicated that the TAS was creating an OER/ZTC Strategic Plan, based on the work that Sarah Harmon and Diana Tedone-Goldstone did through the Regional Leaders of Open Education program in the fall. This evolved into the [OER/ZTC Implementation Plan](#), which is out for review.

This plan lays out the work that has been done thus far with respect to OER/ZTC work, and includes a 'state of OER/ZTC' for this academic year. We then lay out our plans for the next 5 years, with both mid-range goals and end-of-term goals. With a strong connection to work in Diversity, Equity, and Inclusion, the intent of the Implementation Plan is to ensure that our students and our community have full access to the education that they need and desire—and that open educational resources and zero-cost course materials are an integral part of all efforts to address those needs and desires.

At this stage, the draft is ready for comments. With the link, all SMCCCD employees have access to comment on the draft. We ask that employees only add margin comments; please don't change the wording inside the document. This draft has been shown at Academic Senate for a first read, and will also be discussed at the following participatory governance meetings:

- Distance Education Advisory Committee (DEAC): 3 March
- Instructional Planning Council (IPC): 4 March (first read)
- Curriculum Committee: 11 March
- ACES: 22 March
- Instructional Planning Council (IPC): 15 April (second read)
- Academic Senate: 28 April (Proposed; final read)
- Planning and Budgeting Council (PBC): 4 May (Proposed)



# Focus Topic: Online Homework Costs Rising

Replacing commercial textbooks with OER reduces the cost of education. It also reduces the profits publishers make. Many publishers are seeing the writing on the wall and shifting to a digital first strategy that provides textbooks at low cost or free. But bundling them with online homework systems.

Originally free to textbook purchasers, online homework systems are becoming many publishers' primary revenue source. They're also replacing textbook costs as a major hurdle for students. Between 2017 and 2020 Pearson, who announced a digital first strategy in 2019, saw the percentage of their total revenue shift from 59% digital in 2017 to 73% in 2020.

Shifting to OER textbooks makes your class more affordable and accessible, but how are you providing exercises and assessments? Are many of us trading one for profit service for another?

You have options. While systems from major publishers have risen in cost steadily, many smaller companies are entering the market. Publisher agnostic, for-profit systems like Activ Learning and TopHat can double as in-class active learning platforms (online or in person) and are mobile friendly. They can also reduce student costs to a third of what major publishers charge.

OER homework is also an option. Building a reusable online homework system for your department can be as simple as a Canvas quiz or printable worksheet scanned back in with CamScanner. More ambitious projects that support randomized questions and auto-grading can be generated with OER systems like MyOpenMath, WebWork, or LibreTexts Query.



# IDEA OF THE MONTH

## Marking your courses for OER/ZTC in WebSchedule

Spring 2022 was a great milestone for OER/ZTC courses in WebSchedule--we had a record number of sections and courses that were marked as either ZTC (zero-cost) or LTC (all materials at the Bookstore cost \$40 or less, in total). The course materials were a combination of open educational resources, websites with public domain information, and articles culled from a variety of databases. Great work!

But we also know that there are more faculty who are using OER in their coursework, and would have their courses qualify for ZTC labeling on WebSchedule. We want to get all of that information out to the students! Why? Because if we mark all of our ZTC and LTC courses, then students will have more options--the more ZTC and LTC options they have, the more students can save money on their course materials.

As you set up your course materials for Summer 2022 and Fall 2022, make sure you follow the procedures:

### **Step 1: Let Jai know**

You have ways of indicating this on any of the above-mentioned methods of reporting your adoption. If you are using a series of open-source materials, then please indicate that on your adoption submission. This is so that your materials can be verified that they do not infringe on copyright laws, or are indeed open-source.

### **Step 2: Let your division assistant know**

Next, you need to let your division assistant know that you're using these materials, so that your course can be labeled in WebSchedule accordingly.

- If you are using all free and/or open-source materials, then your course will be labeled ZTC (zero textbook cost).
- If you are using an open-source textbook and an additional material (e.g. lab kit, homework platform) that is \$40 or less, then your course will be labeled at Low-Cost OER. (If you don't know how much your materials cost, contact Jai.)

Please email your division assistant, copying Sarah Harmon ([harmonsmccd.edu](mailto:harmonsmccd.edu)), to let them know. Your division assistant will input that information into Banner, which will then display it correctly on WebSchedule. Sarah will follow up with you to collect a list of what you're using.


### **Want your materials on reserve at the Library?**
