ZTC Adopters—Spring/Summer 2022 Cohort

Calling all who are ZTC Curious! We're opening up applications on 14 March for the <u>ZTC Adopters Program</u>. Any faculty who would like to receive support for either adopting OER and other zero-cost materials for one of their courses, or to remix existing materials to better address their course, we invite you to apply for this year's program. Important information:

- Adoption of materials: \$750 award per course. (2-3 awards will be funded)
- Remixing of materials: \$2,000 award per course. (2-3 awards will be funded)
- All faculty are encouraged to apply—full-time or adjunct.
- Faculty can work together on a project, although we don't recommend more than 2 faculty work on a single project.
- Faculty will receive training and needs assessment in May, work throughout June and July with support from the OER/ZTC Coordinator and the OER Librarian, and turn in their final project by 29 July 2022.
- All projects must be for courses that will be taught in the next calendar year.
