 - ii. ZTC funding through FCI: At the February Board Budget Retreat, a presentation on Free College Initiative funding was given...with no mention of ZTC. (Our initial ZTC funding came from the Board in 2022.) For now, the District is not going to give the colleges funding for ZTC directly; the expectation is that colleges will institutionalize the programs. TASW will do a board session on the impact of initial funding soon, with the hopes of being able to show a need for continual support.
- III. SMCCCD ZTC Enrollment Dashboard (15 minutes; Information/Discussion)
 - a. Discussion about the data, next steps
 - i. This dashboard is at the request of the TASW so that we can have enrollment data and have it publicly viewable.
 - ii. Sarah should be getting her PRIE-gathered data on success, retention and persistence, along with fill rates, very soon; we'll look at it in March ahead of other presentations that TAS will be asked to make.
 - iii. The AB1705 group is trying to understand the best combination of high-impact practices for students and their success. There is a disparity with students in high need in online modalities. 1,084 students have declared pathways, looking to help them in their course selection. Wondering if ZTC enrollment data can be pulled in there to address some issues.
 - iv. Would be good to see if transfer rates are impacted by ZTC—related to zero-cost pathways. Sarah will follow up with PRIE.

 - i. 4 projects for Spring 2024 cohort:

 - ii. Thanks to the work by the BUS faculty, this will soon be another zero-cost pathway!

b. Input area: Remixes—reworking the definitions to include Canvas sandboxes?

- i. Sarah took the discussions from January and formalized them, created new potential categories.
 - 1. Will still have to coordinate a bit across TASW.
- ii. Elements to add:
 - 1. Connecting with the possible visual arts studio (Menlo/BDW) to get help with graphics, videos, etc.
 - 2. Accessibility checking should be added to all areas
 - 3. List out which personnel would be involved in projects (beyond Sarah and Diana)
- iii. TASK: Continue reviewing the document; we'll come back to this in our March meeting.
