



## Q1 - What did you submit via Nuventive/Improve this year? (check all that apply)

The review questions and flow are fine. However, the feedback form needs to be changed to just a comment form for each of the questions asked and responded to by the peer reviewers, as the check boxes mostly do not apply to the questions asked and are unnecessary.

If this is in reference to the program review questions, I think we should look at whether any can be eliminated or merged. There seems to be some repetition and it's long. Everything went well though. Just one point: I think the SLO/PLO limits and requirement of numbers did not really fit. It forced us to enter something that did not totally make sense. We explained it in the narrative, but I wonder if that part can be improved. In general everything was a great improvement all around this year though.



However, I have found Nuventive to be very frustrating to use in the past, with bugs in various places. I've had to redo complete sections in there because of this. I hope that Nuventive continues to improve the software and usability, as this is one part of the program review process that I don't look forward to.

Student servies needs to do some work. The peer review process this year, in my opinion, happened extremely poorly with some departments not gathering to meet and an apparent old peer review sheet being used. There were numerous meetings cancelled and it caused some major confusion as well as lack of inter-department work that usually is needed for program review.

I think we just need to make sure we have enough analysts in PRIE and that they have enough time.
