Career Education has traditionally served underprepared and disadvantaged populations to be quickly capable of working and earning decent wages. Housing the largest CE program at Cañada, Education & Human Development contributes to all three goals articulated in the Ed Master Plan.

Goal #1. Student Completion/Success – The department provides the following:

- HS Articulation Agreement; Dual Enrollment at Hillsdale/Carlmont;
- OER for textbooks in many required courses;
- Apprenticeship Program and other support student internships in process;
- Service learning opportunities;
- Mentorships to improve connection of students to local organizations and employers, including active student club.

Goal #2. Community Connections - The department provides a significant service to the San Mateo County population by being the premier program preparing individuals to work in the hundreds of early childhood centers and over 600 licensed family child care homes, and by educating future elementary school and special education teachers.

EHD also establishes structures and resources to initiate and build relationships with local businesses and industries for developing institutional partnerships.

EHD's Educators Now Club is in process of publishing a children's book and workbook about nurturing resilience during the pandemic to families and early childhood centers in our communities.

In collaboration with the San Mateo County of Human Services, EHD manages the Foster Care and Kinship Education (FKCE) program that provides trainings for foster families in the county. EHD has worked with San Mateo's Human Services Agency (HSA) for years, and the partnership continues to strengthen and expand.

Goal #3. Organizational Development – The Education and Human Development is growing in response to both economic and sociopolitical needs and trends. The department is currently engaged in developing/enhancing the following:

- Guided Pathways for students to efficiently complete academic and professional goals;
- Addition of Human Services program into department to strengthen and complement EHD's existing FKCE program;
- Creation of certificates to address educational needs of school districts, e.g., Inclusion Support Certificate to train paraprofessionals to work with children with special needs in a variety of inclusive and self-contained learning environments; After-School Certificate to train those who work in various after-school programs like the Boys and Girls Club, YMCA, etc., and potential work-experience internships related to these certificates;
- Continuing compliance with evolving California Teacher Credential Curriculum Alignment Project and Permit Matrix;
- Student club participation in local education-related conferences and community service.

With an annual unique headcount in 2017/18 of 796 students earned 153 degrees the EHD Department continues to be one of the leaders in degrees and certificates. 8. How would your program be impacted if this position is not continued?

It is unclear how many of the above listed functions would continue if dedicated time were not allotted to a faculty member to plan and accomplish them. So much of what we do is accomplished through the maintenance of ongoing relationships: students, community colleagues. And these relationships take time to create and maintain. Particularly important in the upcoming years is the new requirement of CA Commission on Teacher Credentialing for every ECE program to be certified. This certification process will be rolled out over several years and include complete course revisions that abide by the newly adopted Program Guidelines, Teacher Performance Expectations (TPEs) and commensurate and Performance Assessments. Failure to achieve certification would mean that students would not be able to take ECE courses at Cañada.
