### **Participatory Governance Survey Results Released**

Thank you to the 46 faculty, staff, students and administrators who responded to the Participatory Governance Survey last spring. This survey is an important part of our regular evaluation of how well our participatory governance structures and processes are working. In general, the survey found that members of participatory governance committees tend to rate themselves as having a better understanding and a more positive opinion of participatory governance than non-members. Additionally, those who indicate a greater understanding of participatory governance tend to have a more positive view of it. Most respondents indicated that they were familiar with the District's Strategic Plan. However, some respondents felt that there was not a clear division of authority and responsibility between the District Office, the Board of Trustees, and Cañada College.
