### Construction Website

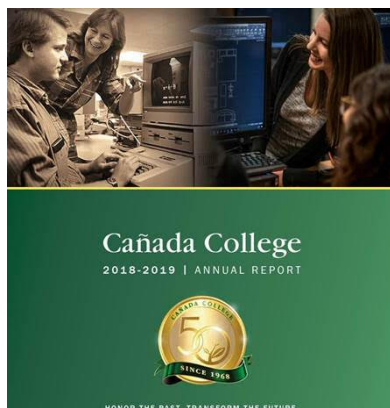

## **Faculty Reassigned Time**

The Instructional Planning Council in collaboration with Academic Senate has worked to refine the Reassigned Time Application Process. There is now a separate application for NEW position proposals and RENEWALS. Please review the new process that is listed below.

### *Deadlines:*

NEW and RENEWAL applications are due November 15 to your dean. Deans will have a week to review the applications before forwarding them to the Office of Instruction.

### *Applications:*

The NEW reassigned time position proposal is now shorter. You can access the application [here](#). The RENEWAL reassigned time position proposal now consists of just two questions. You can access the application [here](#).

### *Results:*

Applications will be reviewed by IPC during their December 6th meeting. Informed by the feedback provided by IPC, the VPI will announce which proposals for reassignment have been approved and denied by **Friday, December 13th**.
