- The Marketing Department worked with the City of East Palo Alto to create banners which celebrates alumni and highlighting our Free College program.
- This was a first-time project that involved close collaboration with the City - developing a posting policy, securing City Council approval, designing the banners and coordinating with multiple vendors to make it happen.
- We’ve also begun conversations with the City about expanding the banners into additional areas of East Palo Alto.
- The City is currently reviewing options, and we expect to know next steps by the end of October.

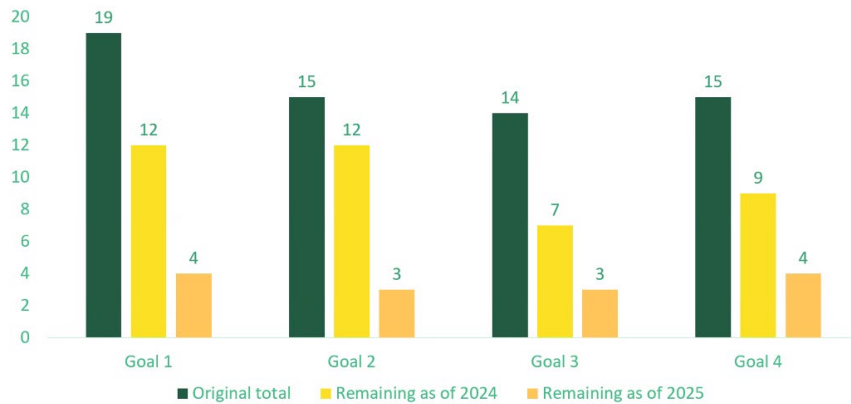

Priority Initiatives Selected for 2025-26

Goal 1: Student Access, Success, and Completion

- 1.15 Create and scale the First Year Experience Program

- 4.1 Improve access to campus via public transit, rideshare

Goal 1: Student Access, Success, and Completion

- Initiative: Expansion of First-Year Experience program, building on the existing Promise program.
- Action: Collaborate with Academic Senate to review and ensure academic program viability.
- Rationale: Programs must align with current community needs and maintain long-term relevance.

Goal 2: Equity-Minded and Anti-Racist College Culture

- Focus: Evaluate and improve hiring practices to ensure diverse applicant pools.
- Partnership: Collaboration with District HR to align practices and priorities.
- Objective: Better reflect and serve our diverse student population.

Goal 3: Community Connection

- Vision: Re-envision career services at Cañada College.
- Community Input: Demand for "learn-and-earn" models, internships, and apprenticeship opportunities.
- Call to Action: Staff and community members with industry ties are invited to join a career services task force, co-led by VP Lizette Bricker.
- Special Focus: Integration with Menlo Park Center and college-wide support for workforce development.

Goal 4: Accessible Infrastructure and Innovation

- Challenge: Loss of pandemic-era funding (e.g., shuttles, Lyft programs) for transportation access.
- Current Efforts: Exploring new transportation solutions for East Palo Alto (EPA), Belle Haven, and North Fair Oaks.
- Priority: Improving ease of access to campus remains a high priority.

Update: Child Development Center

Ludmila Prisecar, Vice President of Administrative Services, provided updates on the Child Development Center (CDC).


- This project has been over 20 years in the making.
- CDC aims to support both students and the local community.
- Construction Completion: Expected by Winter 2026.
- Facility Opening: Spring 2027

Patty was hired decades ago to lead the original, unfulfilled plan and has been instrumental in bringing the current project to life.</p>
Institutional Self Evaluation	<p>Karen Engel, Accreditation Liaison Officer and Dean of Planning and Research (PRIE)</p> <ul style="list-style-type: none">• Comprehensive Institutional Self-Evaluation Report (ISER) is currently in draft.• Members of the President’s Advisory Council are requested to review the current ISER Draft and submit any comments or suggested changes in the document or via email to Dean Engel by October 3, 2025. <p>Key Accreditation Standard Highlighted (1.5):</p> <ul style="list-style-type: none">• ACCJC Standard 1.5 requires institutions to “regularly communicate[s] progress toward achieving its mission and goals with internal and external stakeholders in order to promote understanding of institutional strengths, priorities, and areas for continued improvement.”• Dean Engel walked the Council through the current draft response to this standard, highlighting the importance of the Council and many of the partners represented on the Council as well as others.
