Dear Colleagues, this is the second of the three enrollment updates for this term. The dates for the three updates are: the End of the First Day of Classes ([January 22](#)), the Last Day to Add/Drop ([February 4](#)) and the Official Census Day ([February 17](#)). The Board of Trustees receives formal reports from my office on the data from the Official Census Day. Please note there is a two-week delay in certifying the Official Census Day data.

*Special Notice: To make our productivity reports more accurate, effective fall 2010, contract courses (attendance method = OC) are excluded from Enrollment, FTES, WSCH, Load and Sections. Data from all prior terms still include these courses, however, the impact of this change is expected to be small. Starting fall 2011, we have added "internet" to reflect distance education enrollments. Note: Change refers to the difference in percentages from a comparable day a year ago. For Spring 2015 the change is computed by the first day of classes started on 1/13/14.

\*FTES: Full Time Equivalent Student. It is point in time and will change as the semester progresses.

\*\*Load: Teaching Load is taken as the ratio of WSCH to FTE. It is point in time and will change as the semester progresses.
