8:45 a.m. – 9:45 a.m.	<p>Keynote Speaker - Jonathan Lightman was selected as executive director of both the 11,000 member Faculty Association of California Community Colleges (FACCC) and the FACCC Education Institute (EI) in 1999. In this capacity, he serves as senior staff to the following entities: FACCC Board of Governors, FACCC EI Board of Directors, Legislative Committee, Political Action Committee, and Policy Committee. As FACCC's senior lobbyist, Jonathan focuses his advocacy work on the State Budget, federal legislation, and regulatory matters.</p> <p>Prior to joining FACCC, Jonathan served as director of government relations and political affairs for the National Association of Social Workers, California Chapter. In that capacity, he directed all aspects of governmental and political advocacy for the 12,000-member organization, and mobilized 1,000 social workers in the "Social Work '96" campaign to participate in the 1996 elections.</p> <p>As a contract lobbyist, Jonathan has lobbied on behalf of such interests as the State Bar of California, the California Trucking Association, the Greater Oakland International Trade Center, the Anti-Defamation League, and the Reading Specialists of California.</p> <p>Jonathan received his Bachelor of Arts in Politics from Brandeis University in 1983, where he graduated Magna Cum Laude and received departmental honors in Politics. He received his Juris Doctor from the University of Southern California School of Law in 1986, where he served on the Hale Moot Court Honors Program and received the Shattuck Award for excellence in legal service. Online Flex Opportunity

[ACCJC Basics Online Course](#) - This self-paced, online course offers participants the opportunity to become more familiar with accreditation standards and practices. It is divided into sections that define accreditation, identify the standards, discuss areas of concern, and explain the accreditation process. At the completion of the course, **participants are expected to score a minimum of 85% on the end of course quiz**. Those who successfully complete the online training will receive 1.5 hours of Flex time (this includes 1.5 hours of compensation for adjuncts eligible for compensation on this Flex Day. Note: the course needs to be completed before September timesheets are due.) In order to receive Flex Credit or compensation, participants need to submit a copy of the successful completion certificate with Flex reporting documentation. Those who complete this course will be able to:

- Describe the role of the federal government and the U.S. Department of Education with regard to accrediting schools, colleges, and universities
- Explain the organization of accrediting commissions in the United States
- Explain the organization and purpose of the Accrediting Commission for Community and Junior Colleges (ACCJC)
- Identify resource documents published by the ACCJC
- Explain the purpose and process of accreditation
